



TRIP TERMS AND CONDITIONS

INSURANCE

W:W strongly encourages all participants to have traveler's insurance, both medical and trip insurance. The purpose of this is to protect you from the unexpecteds that sometimes come with travel – things like delayed flights, medical emergencies, etc. Appropriate traveler's insurance may also cover you in the event that you need to cancel your trip.

PARTICIPATION

W:W is committed to making this trip fun and safe for all. If a guest misbehaves or does things that are incompatible with the safety, comfort or convenience of other members of the tour, W:W has the exclusive right and discretion to expel someone from a tour at any time.

SAFETY

While W:W will do everything possible to ensure safety for all, please understand that each traveler is ultimately responsible for his/her own safety. If something feels unsafe or if a situation is making you uncomfortable, come talk to us! And ultimately, please listen to your feelings and take care of your safety.

PAYMENT SCHEDULE, CANCELLATION and REFUNDS

Your Choice Package:

Payment Schedule: The full "flat fee" is due within 14 days of your trip application acceptance.

Cancellations and Refunds: If you need to cancel:

- 1) No refund of the "flat fee" will be given unless:
 - a. If you find a suitable replacement traveler (all applicants are reviewed by W:W and application approval is at the sole discretion of W:W) to take your spot prior to the "application deadline" (as specified for the trip for which you have applied for) you will be issued a refund of your "flat fee" minus:
 - i. \$100 Cancellation Fee

Failure of the traveler to make payment as scheduled above ("Payment Schedule") results in forfeiture of the trip.

If Wanderlust:Wanderlearn needs to cancel a trip for any reason, you will receive a full refund of your "flat fee".

Standard Packages and All-Inclusive Packages:

Payment Schedule: A 50% deposit is due within 14 days of your trip application acceptance. The remaining 50% is due 30 days prior to trip start date.

Cancellations and Refunds: If you need to cancel, you have several options:

- 1) Cancellation earlier than 180 days before the trip start date: you will be refunded your deposit minus:
 - a. \$275 Cancellation Fee
 - b. Costs incurred by Wanderlust:Wanderlearn for booking flights in your name. Applicable only to trips that include flights in the trip terms.
- 2) Cancellation between 180 – 30 days before the trip start date:
 - a. If you or W:W can find a suitable replacement traveler to take your spot (all applicants are reviewed by W:W and application approval is at the sole discretion of W:W) you will be issued a refund of your deposit minus:
 - i. \$275 Cancellation Fee
 - ii. Costs incurred by Wanderlust:Wanderlearn for booking flights in your name. Applicable only to trips that include flights in the trip terms.
 - b. If you wish to cancel without a replacement: No refund will be issued.
- 3) Cancellation 30 days and after, prior to the trip start date: No refund will be issued.

Failure of the traveler to make payments as scheduled above ("Payment Schedule") results in forfeiture of the trip and no refunds will be issued.

If Wanderlust:Wanderlearn needs to cancel a trip for any reason, you will receive a full refund of fees paid to W:W.

WAIVER, RELEASE and HOLD HARMLESS

I understand that during my participation in this Wanderlust:Wanderlearn Trip, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in each Trip and cannot be eliminated without destroying the unique character of the Trip. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death from exposure to the hazards of such a trip.

I know that injuries and damages can occur by natural causes or activities of other persons, animals, trip members, trip leaders and assistants or third parties, either as a result of negligence or because of other reasons. I understand that risks of such injuries and damages are involved in adventure travel such as Wanderlust:Wanderlearn Trips and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I further understand that on this Trip there may not be rescue or medical facilities or expertise necessary to deal with the injuries and damages to which I may be exposed. In consideration for my acceptance as a participant on this Trip, and the services and amenities to be provided by Wanderlust:Wanderlearn in connection with the Trip, I confirm my understanding that: "I have read any rules and conditions applicable to the Trip made available to me and I acknowledge my participation is at the discretion of the leader."

The Trip officially begins and ends at the location(s) designated by Wanderlust:Wanderlearn. The Trip does not include carpooling, transportation or transit to and from the Trip, and I am personally responsible for all risks associated with this travel.

I agree to indemnify and hold harmless Wanderlust:Wanderlearn, LLC and any agents thereof, personally or otherwise, of all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or in part by the negligence or other fault of the Released Parties.
